

**Woodbury County Fairgrounds**  
**Full Hook-Up Camping Rules and Regulations**

1. The following rules and regulations will be adhered to by all campers. After a warning is given or being a habitual violator, you may not be allowed back in the campground area. The Woodbury County Fair Association reserves the right to examine each situation on a case-by-case basis.
2. Pets must be on a leash or in a kennel at the camper's designated site. Campers are responsible to clean up after their pet. Pets are not to be turned loose on the fairgrounds.
3. Camping registration must be an adult (aged 18+) listed on the registration form.
4. All campers must back into their designated camp site. Pull through spots are not available. Visitors are asked to leave the campground at 12 midnight.
5. Excessive noise will not be tolerated. Please be respectful of your neighbors in all ways, including language, children, etc. Quiet time begins at 11 o'clock.
6. Campers are asked to maintain the area assigned to them. Dumpsters will be provided.
7. Fires are allowed as long as the fire pit is self-contained, raised off the ground, and 10 feet of space away from any other structure.
8. This camping site is full hook-up, with grass spots. Use boards to level camper. Do not dig holes to level.
